### **PHOTOGRAPHIC USE CONTRACT**

- 1) This permission is for the use of the photographic materials listed in the Permission for Publication. Only photographic materials supplied by the Lee-Fendall House Museum are permitted to be reproduced.
- 2) Unless otherwise stated, failure to pay the required fees for reproduction means that permission for use has not been granted.
- 3) Permission is only granted for one-time use. For re-use of photography, a new permission form must be obtained and appropriate fees paid.
- 4) The reproduction must not be cropped, bled off the page, printed on color stock or with colored ink, nor have anything superimposed on the image. Each image must be reproduced unaltered, in its entirety, unless approved in advance, in writing, by the Museum Director. When a detail is used, the word *detail* must appear in the credit line.
- 5) The full credit line, exactly as supplied on the Permission for Publication, must appear in immediate proximity to the image or in the section devoted to photographic credits. No abbreviations are permitted. In the case of motion pictures, television, or educational filmstrips, the credit line must be included in the final credits.
- 6) All negatives, inter-negatives, and color transparencies remain the property of the Lee-Fendall House Museum. An overdue fee is charged for every month beyond the initial three-month period that these materials are in the possession of the borrower. A charge equal to the replacement cost will be levied for each damaged transparency.
- 7) This permission is valid only for the individual, company, or institution to whom it is specifically issued, and may not be transferred, assigned, sold, or otherwise disposed of without the written permission of the Museum Director.
- 8) When used for promotional purposes, references to the Lee-Fendall House Museum, outside of the original copyright notice, if any, are not permitted unless particularly applied for and granted in writing.
- 9) Photographic materials shall not be used to show or imply that the Lee-Fendall House Museum endorses any commercial product or enterprise, concurs with opinions expressed, or confirms the accuracy of any text used with said materials.
- 10) Black-and-white photographs for reproduction are sold outright and are not returnable.
- 11) The permission hereby granted terminates immediately upon publication.
- 12) Any breach of these terms and conditions may result, at the sole discretion of the Lee-Fendall House Museum, in the revocation of permission to reproduce, with the right to seek other remedies, including damages.
